#### **Exposures for Dealer & Repair Businesses:**

Most dealerships, auto repair shops, gas stations, and other related businesses have a pollution exposure—oil/grease spills, hydraulic lifts, and chemical/pesticide storage are common concerns at these facilities. Golf courses have pesticides, fuel or batteries for golf carts, equipment maintenance facilities, and other chemicals. In addition to these concerns, many facilities typically have aboveground storage tanks with capacities of up to 550 gallons, which means that the tanks are not regulated by the states and therefore do not require Financial Assurance. In the absence of a requirement for coverage, many forgo purchasing it. Unfortunately, experience shows that pollution losses from these types of facilities happen all too frequently, and have a significant financial impact on the business.
